PEACEMAKING GRANTS

The Presbyterian Church recognizes that the church is faithful to Christ when it engages in peacemaking. On World Communion Sunday in October a peace and global witness offering is received in most Presbyterian churches. The offering supports efforts to promote peace by individuals, congregations, presbyteries, synods and PCUSA at home and around the world.

The portion of the offering available to Transylvania Presbytery is administered by the Mission Ministry and awarded in grants to individuals or churches engaging in peacemaking either through service or education. As the amount made available through the peacemaking offering varies from year to year so do the number and size of grants. Awards will serve to supplement the funds provided by the applicants to carry out the described projects. The grants seek to support those efforts, which give overt and particular witness to the Lordship of Jesus Christ.

The attached application provides an outline for the information that should be provided about how the funds awarded will be used. Applications for Peacemaking Grants are due in the Transylvania Presbytery Office by November 1. Awards will be announced in early December.
